APPROVED PENALTY FOR OPERATING A MOTOR VEHICLE WHILE UNDER THE

INFLUENCE OF A DRUG, CONTROLLED SUBSTANCE AND/OR CONTROLLED

SUBSTANCE ANALOG

While Wisconsin Law 363.63, operating under the influence of an intoxicant or other drug was adopted by the Tribe, the Menominee Supreme Court has never officially designated the penalty for operating or driving while under the influence of a drug/controlled substance/controlled substance analog. This law, 363.63 (1)(am), states that it is against the law to operate or drive with any detectable amount of a restricted controlled substance in their blood. In the past, the judges have imposed the penalty equated with the lowest level accorded for alcohol/BAC amounts.

Effective immediately, the Supreme Court now officially established that the penalty amount for .149 or lower shall be the same penalty for individuals cited for operating or driving under the influence of a drug, controlled substances and/or controlled substance analogs or any combination thereof.
